These key child abuse prevention programs teach strategies for handling challenges, understanding developmental milestones, and provide opportunities for parents to connect with one another for support. We know that effective implementation of these programs is crucial to ensuring parent support programs achieve intended results and has critical social, economic, and public health implications for our state. Research shows that programs are most effective when providers
